The paperwork for the Chamber of commerce was received in the mail, it will be filled out and turned in so we can be listed with the Chamber.

It was asked if hunter safety would be held this year, no one knew the status, but we will reach out to Montana Fish and wildlife.

The range flags have seen some wear this year, and it was thought we should purchase new ones so we can replace them when they are worn out. And we should remove them in the winter to save damage to them.

It was also discussed that we need to purchase a new American Flag. That way we have back up that when one needs replaced, we have the new one on hand. Joanne Cummins Said she would look into the American Legion flags and forward the info to us.

With no more business to discuss a motion to adjourn was made by Pat McCoy, seconded by TJ Paulsen.
